REGULAR CONTRIBUTION *made through direct debit service*


- Complete and submit the Application Form – “Easy Gold Plan” [FORM: AP (SVC) – MT or AP (SVC) – IS] to BCT.
- The minimum amount of monthly regular contribution is HK\$300 and it may take 4 – 6 weeks for processing the direct debit set up.
- Upon completion of your enrolment and direct debit set up, you will receive a confirmation package from BCT.
- The confirmation package will state the effective date of direct debit and the contribution will be debited from your designated bank account automatically on a monthly basis.

LUMP SUM CONTRIBUTION *made by cheque payment*


First Contribution

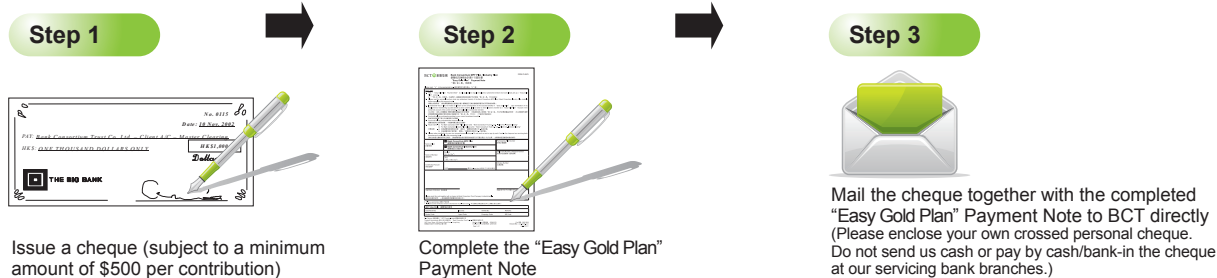


Please write “Easy Gold Plan”, your name, your HKID card / passport number and the Participating Plan Number (stated on your membership certificate) on the overleaf of the cheque


